- Name local resources for victims of domestic violence, and be able to make appropriate referrals

Trainers

Susanna Gilbertson, MSW is the Training and Education Supervisor for the Lutheran Settlement House's Bilingual Domestic Violence Program. Ms. Gilbertson has created and facilitated interactive workshops on topics including sexual health, suicide prevention and intimate partner violence for youth, professional and community groups. Ms. Gilbertson's experience includes work in an emergency domestic violence shelter & supervision of a peer help line for teenagers.

Ewa Janczewska, MED is an Intake Advocate/Community Educator for the Lutheran Settlement House's Bilingual Domestic Violence Program. Ms. Janczewska has worked in the domestic violence field for the past three years. Ms. Janczewska has facilitated support/educational groups for survivors of domestic violence and worked on developing a curriculum for parents who face challenges of parenting after violence. Ms. Janczewska's experience includes working with survivors of domestic violence in Poland, work in an emergency domestic violence shelter, as well as in a homeless shelter for women and children in Philadelphia.
